If the Instrument has not been paid, I/we hereby request you to place a "stop payment" against it and do one of the following as indicated below:

- issue and deliver to (name/NRIC) _____, in lieu thereof, an Instrument for like amount payable to the order of the same payee.
- refund to me/us the face amount of the Instrument.
- refund to me/us the equivalent in Singapore Dollars at the rate of exchange prevailing in Singapore on (date dd/mm/yyyy) _____.

I/We understand and agree that if the Instrument is presented for payment by the payee (or purportedly by the payee) or if the Instrument purports to bear the payee's endorsement, you may be compelled to pay, in which event I/we agree to reimburse you for the amount of the Instrument.

In consideration of you acting in accordance with the terms of this instruction, I/we agree to indemnify you and keep you indemnified against all demands, actions, proceedings (whether groundless or not), liabilities, claims, damages, losses, costs and expenses (including without limitation legal fees on an indemnity basis) of whatever nature and howsoever arising that you may incur or sustain by reason thereof now or at any future time.

Further, I/we agree that you will not be liable if the Instrument is paid by mistake or as a result of incorrect information given to you. Should the Instrument be found, I/we will promptly deliver the same to you for cancellation.

The termination of the terms of this letter shall not release me/us from any liability in respect of any request made to stop payment prior to the time of such termination.

This letter shall be governed by and construed in all respects in accordance with the laws of the Republic of Singapore and I/we hereby agree to submit to the non-exclusive jurisdiction of the Courts of Singapore. A person who is not a party to this letter has no rights under the Contracts (Rights of Third Parties) Act (Cap. 53B) to enforce any term of this letter.
